

**INTEL SOFTWARE BILL OF MATERIALS ("SBOM") TERMS OF USE**

Intel Corporation and its affiliates ("Intel") provides the attached SBOM to Recipient under the following terms of use ("Terms of Use")

**1. DEFINITIONS.**

- a. *"Affiliate"* means any entity that Controls, is Controlled by, or is under common Control with a party.
- b. *"Control"* means direct or indirect ownership, through one or more intermediaries, of more than 50% of an entity's voting capital or other voting rights.
- c. *"Government Entity"*: means a department or agency of any Country or State or any political subdivision thereof.
- d. *"Intel"* means (1) Intel Americas, Inc. for any PRM delivered to Recipient within the United States; and/or (2) Intel Technology (US) LLC for any PRM delivered to Recipient outside of the United States.
- e. *"Intel SBOM"*: means an SBOM produced by or on behalf of Intel regarding Intel products.
- f. *"SBOM"* means an electronic file containing details of ingredients included in a particular named product.
- g. *"Recipient"* means the person or entity receiving the SBOM from Intel, via Intel's Resource & Documentation Center download or otherwise.
- h. *"Recipient SBOM"* means an SBOM produced by or on behalf of Recipient regarding Recipient's own products.
- i. *"Third-Party Entity"* means an entity who is not a party to these terms.

**2. APPLICABLE TO SPECIFIC SOFTWARE.** The Intel SBOM provided reflects and is applicable only to the product which it accompanies or refers to and is not interchangeable with other products, even those similar in name or feature. Refer to the specific SBOM labelled for a specific product for accurate SBOM details.

**3. UPDATES/AMENDMENTS.** Each Intel SBOM will refer to a specific product version by number. The Confidentiality obligations (Section 5) and restriction of use (Section 6) of these terms of use will survive the termination of these terms and the publication of any replacement Intel SBOM.

**4. CONFIDENTIALITY.**

- a. Generally. The SBOM, and Recipient's use of the SBOM, including any knowledge of or information about Intel's raw materials, or product components, are "Confidential Information" and are subject to the CNDA in place between You and Intel. SBOM may only be disclosed to Third-Party Entities for the applicable Restricted Use (Section 5) under a non-disclosure agreement or equivalent law or regulation, using the same degree of care to protect the SBOM that Recipient uses to protect its own confidential information, in compliance with these terms of use. In the event of a conflict between these terms of use and the CNDA, these terms of use will prevail. Recipient must not make public statements or representations about the SBOM, its contents, or legal sufficiency unless expressly authorized by Intel in writing.

**5. RESTRICTED USE.**

- a. Recipient may:
  - i. Use the SBOM internally to investigate and track common vulnerability exposure and other product security issues.
  - ii. Provide the Intel SBOM to a Third-Party Entity that is an established or potential customer or Government Entity, subject to the terms of Section 4 above, for regulatory or contractual compliance, either as a standalone file or incorporated into Recipient SBOM.
- b. Recipient may not:
  - i. Use the Intel SBOM for reverse engineer any Intel product or process.
  - ii. Monetize the Intel SBOM without Intel's prior written approval. For the sake of clarity, this shall not limit the Restricted Use as described in Section 5a.

**6. DISCLAIMERS.** The Intel SBOM is provided "as is" to the best of Intel's knowledge and may include elements provided by third parties. Intel does not guarantee your compliance with any requirements, regulatory, standards-based, contractual or otherwise, by providing this SBOM. The SBOM Recipient receives, incorporates, and uses the SBOM at its own risk, in accordance with the terms and conditions agreed to by the Recipient upon receipt of the SBOM, which include limits on Recipient's ability to redistribute the SBOM. Intel disclaims all warranties whatsoever, express or implied, including but not limited to warranties of merchantability, fitness for a particular purpose, and non-infringement of others intellectual property. Intel will not be liable to Recipient for any direct, indirect, punitive, incidental, consequential, or special damages of any kind resulting from Recipient's use of the SBOM even if advised of the possibility of those damages.

**7. ASSIGNMENT.** Recipient's rights and obligations under these terms of use are not transferable or assignable. Intel may assign or delegate its rights and/or obligations, in part or in whole, under these terms of use to any of its affiliates.

**8. GOVERNING LAW AND JURISDICTION.** These terms of use are governed by USA and Delaware law and all disputes and actions arising out of or related to this IPLA will be subject to the jurisdiction of the courts located in Delaware.
